



North Fremantle dinghy management storage system

In accordance with the Department of Parks and Wildlife Corporate Policy Statement No. 45 *Planning for miscellaneous structures and facilities in the Swan Canning Development control Area*, the City of Fremantle has provided a dinghy storage facility, managed by the City according to the rules set out below.

RULES

1. The dinghy storage facility is located at Prawn Bay Reserve, Johannah Street, North Fremantle.
2. The number of dinghies stored at the facility will not exceed forty-eight (48), and may be less than, the number of moorings adjacent to Prawn Bay Reserve, North Fremantle, registered with the Department of Transport (DoT) or its successor.
3. Only dinghies will be stored at this facility. No trailers are allowed.
4. Allowable length for a dinghy is not to exceed 10 feet or 3.5 metres.
5. Please be mindful and respect other's dinghies and foreshore users.
6. Dinghies are stored at the facility at the owner's risk; the City accepts no liability for any damage or loss.
7. Dinghies must be chained directly to the length of chain provided and not directly to the bollard. The dinghy owner must ensure that the City's padlock will still free the dinghy from the bollard and allow it to be moved if required; any padlock not connected in this manner may be removed by the City if deemed necessary to do so. It is the allocated bay owner's responsibility to replace their own padlock.
8. Should there be any damage to your bollard or chain, you must inform the City immediately.
9. A dinghy must stay in its allocated spot which is to be given by the City.
10. The City may temporarily move or remove a dinghy from the storage facility for the purpose of performing its functions, or to facilitate other government authorities to perform their functions.
11. All dinghies stored within the municipality of Fremantle not complying with these rules will be reported to the relevant State government authority to apply the *Swan and Canning Rivers Management Regulations 2007*.

Allocation of a dinghy bay

12. Access to the dinghy storage system will be by application with preference given to holders of licenced boat moorings adjacent to Prawn Bay Reserve, North Fremantle, then residents of the City of Fremantle, and then other members of the community and a waitlist will be maintained.

13. Applications can be made at any time through the City's website or by contacting the City on 1300 MYFREO (1300 693 736). Applicants allocated a dinghy storage bay must register details of their dinghy with the City.
14. Registration details including, but not limited to, ownership details, the DoT tender number or other permanent identifier on the dinghy, and owner contact telephone numbers, must be provided to the City. Any changes to these details must be updated with the City immediately.
15. Dinghies must be stored in an allocated storage bay, subject to an annual fee of \$60.50, payable at the time of registration.
16. All dinghy bay registrations expire on 30 September each year. Dinghy bay storage registrations must be renewed by 30 September each year or the bay will be reallocated.
17. All fees must be paid by 30 September each year; unpaid fees will void application and registration and the dinghy bay will be reallocated. Registration and fees will be accepted from 1 July each year.
18. Only one application per dinghy and dinghy owner will be accepted.
19. Applicants on the waitlist will be offered a dinghy storage bay in order of preference as stated in 12 above. If the applicant does not register their dinghy with the City within twenty-one (21) days of the date of offer then the storage bay will be reallocated.
20. Registration will be provided by the City's permit system or other system as deemed appropriate and advised by the City. It is the dinghy permit holder's responsibility to ensure all registration details are correct and current.
21. You may not sublease your dinghy bay registration.
22. You may not transfer your dinghy bay registration to another dinghy or dinghy owner if no longer required, you must return the dinghy storage bay to the City for re-allocation, except:
 - a. When you transfer ownership of your dinghy, provided advice of change of ownership details are given to the City at the time of dinghy transfer.
 - b. When you wish to transfer the registration bay to another dinghy in your ownership. The transfer will not be valid until you have provided advice of the change of registration details to the City.
23. The City reserves the right to terminate a person's registration for failure to comply with these rules or for any other reason it may deem necessary.
24. The City reserves the right to terminate a person's registration for failure to comply with any reasonable direction of the City.
